- should the accused party not appear at the aforementioned hearing, he/she will be sentenced "in absentia"
- the accused party has the right to name one or two attorneys: should he/she not name an attorney, one will ne named for him/her, whose fee will be attributed to the accused party (excepting acknowledgement of legal aid)
- the accused party has the right, having recourse to the aforementioned, to request immediate sentencing, as well as the application of the law under art. 444 and following c.p.p. (criminal procedure codes), during the preliminary hearing, or abbreviated sentencing under art. 438 and following c.p.p. (criminal procedure codes).
