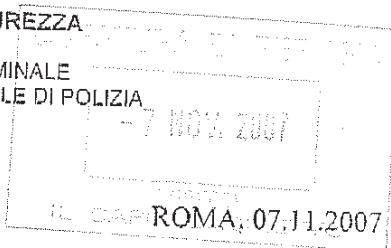

I am the above named person and live at the address overleaf and have done so for the past 20 years. I am a student at Leeds University and have been studying there for the past 3 years. For the past five weeks I have been studying in PERUGIA, Italy.

This is a further statement I have made in relation to MEREDITH KERCHER and our friendship. I made my first statement on Friday 2 November 2007 to Italian police officers.

Since returning to the United Kingdom I have had time to think of events and I would like to bring these to the Police's attention.

I recall a conversation that I had with MEREDITH, I think it was on at about 6<sup>th</sup> October 2007. We were sitting in MERLINS pub in PERUGIA also with us was AMY FROST, SOPHIE PURTON and NATALIE HAYWARD. We were eating pizza we had just watched England play Australia at the rugby. I think it was about 2100 hours at night. At this time MEREDITH drew my attention to a male who had entered the pub. She told me he was a male who had come to her flat with AMANDA, AMANDA being MEREDITHS flat mate. We had recently discussed how Amanda had brought men back to their flat on numerous occasions. This male she had met in an internet café so we called him "INTERNET MAN".

I would describe this male as aged 25-30 years, he was about 6ft tall, he was of average build. He had brown short hair in a messy style. He had a pale complexion, I am unsure of his nationality. He had a shadow of a beard on his face. He wore smart clothes, he wore trousers and shoes with a brown suit style jacket but it was made of a more casual cloth.

I recall seeing this male a week later at approximately 0400 hours in the morning on 14<sup>th</sup> October 2007. We were leaving a disco called GARDISCO which is 25 minutes drive from PERUGIA. My friend SOPHIE PURTON had been ill and had been sick in the toilets at the club. MEREDITH and I were taking SOPHIE out of the club to get the bus home to PERUGIA. The male we know as "INTERNET MAN" tried to speak with MEREDITH. I said to the male we know as "INTERNET MAN" "no sorry we need to get our friend home."

Once outside of the club we found out we had missed the bus home. We then saw a male I know as "shakey". I have since found out his name might be ISHAM. He offered us a lift home, it was a family car. He didn't drive a friend of his drove. I can only describe the driver as dark skinned, dark hair with glasses. During the conversation on the drive home MEREDITH asked "SHAKEY" why he was at the club" this was in Italian. He replied I have three jobs and work at the club. He stated he was a chef,

worked at the club and also we knew he worked in a clothing shop called "STREET DREAMZ" in PERUGIA. We hadn't seen "SHAKEY" all night in the club.

I recall another incident where we were in a club called "DOMUS" in PERUGIA. I cannot recall a time or date but I know I was with SOPHIE PURTON, MEREDITH KERCHER, and 3 girls from Manchester University I know only as Samantha, Charlotte (unclear) and there was an incident where MEREDITH asked "shakey" to dance. At this point I turned away and MEREDITH said "Shakey" pulled his trousers down and showed his "Y FRONTS" to MEREDITH. I didn't see this. Also with us this night was "PISCO" I know as the manager of MERLINS pub.

After the HALLOWEEN party at our flat we went to the club "Darius". It was approximately 0200 hours on 1<sup>st</sup> November 2007. I was in company with SOPHIE PURTON, MEREDITH KERCHER and AMY FROST. During this evening at the club I saw a male we know as "DJ NAF" working behind the bar. This male we know from MERLINS pub where he also worked. AMY FROST told me she had seen this male flirting with MEREDITH. He had been throwing ice cubes at MEREDITH. In my company AMY FROST said to MEREDITH KERCHER "DJ NAF FANCY YOU I THINK."

The next time I saw this male was at approximately 1730 hours on Friday 2<sup>nd</sup> November 2007 while waiting for the Italian Police to collect me from outside the language UNIVERSITY in PERUGIA. At this time "PISCO" the owner manager of MERLINS joined us because he had spoken to SOPHIE PURTON who he was close friends with after hearing of a death of an English girl. In company with him was "DJ NAF". I found "DJ NAF" behaviour strange. He was speaking to "PISCO" in Italian saying "It is MEREDITH" "IT IS HER." He then went onto to detail in Italian of how a body had been found. As I was very upset and still unaware it was MEREDITH KERCHER I told "PISCO" to tell "DJ NAF" to be quiet.

I would describe "DJ NAF" as a Mediterranean male aged about 23 to 28 years old. He is under 6ft tall he has dark hair and eyes and wears glasses. He normally dresses casually in jeans and a jumper. On Friday he was wearing a big blue coat.

I know that "DJ NAF" knew us a group but not that he knew MEREDITH well. On my flight home to the UK on Saturday 3<sup>rd</sup> November 2007 I was in company with AMY FROST. At this time I read an article in "CORRIERE DELLA SERA" there was a quote from a male named PIETRO CAMPOLONGO. I did not know this name so asked Amy if she knew who the male was. She replied "NO." On returning home I spoke to my friend SOPHIE PURTON who was in Italy. She told she knows "DJ NAF" first name as PIETRO, I read her the surname and she thinks that is also his surname. I then went onto to read a quote on the internet from a male with the same name detailing information about MEREDITH and her movements. This concerned me. I think it is important to mention that on Thursday 1<sup>st</sup> November 2007 when MEREDITH KERCHER left our flat she never mentioned she was going to meet anybody and she never stated she would be staying alone in her flat for the night. When she left our flat it was not an arranged time or as if for a pre-arranged meeting.

I would also like to mention that after my interview/statement at the Italian police station I went into the waiting room, it was approximately 2230 hours on Friday 2<sup>nd</sup> November 2007.

In the waiting room was AMANDA - MEREDITH flat mate. I do not know her surname. As I walked into the room she was talking in a loud voice to all the people in the room, the English girls. She was speaking in English. She was saying that she had returned to the flat at about 1100 in the morning. She went on to say that the front door was open, she went into the bathroom that her and MEREDITH shared. She said she saw blood on the floor. I recall her mentioning she thought it was menstrual blood. She then stated she went onto have a shower. I then recall her mentioning going into the other bathroom that LAURA and FILOMENA (other flat mates I share. She said that here was "SHIT" in the toilet. She kept mentioning the word "SHIT". This seemed an odd comment to make as MEREDITH had had an issue with Amanda over not flushing the toilet after using it even for her period. MEREDITH told me she had discussed this with her dad. Amanda continued to talk about how she had found MEREDITH, she seemed

proud that she was the first to find her. She also said she had seen MEREDITH body in the closet with a blanket/sheet over her. Later FILOMENA took me to one side where we could speak privately and she told me she had seen MEREDITH foot on the bed when she and a policeman had opened the bathroom door to MEREDITH room.

I felt AMANDA'S behaviour was very strange in the police station she didn't seem to be behaving as if she was upset. She seemed to be laughing and staring at us. Her behaviour had upset my group of friends.

AMANDA'S behaviour had always seemed strange to me before Friday 2nd November 2007. She seemed a little odd I remember on my first occasion meeting her while eating in a restaurant she burst into song loudly during the meal. It was out of place and very odd.

I also want to mention that I feel that if MEREDITH was going to have a sexual relationship with somebody she would have told me.

## TESTIMONIANZA RESA DA ROBYN CARINEL

Sono la persona sunnominata ed abito all'indirizzo già dichiarato da venti anni. Sono una studentessa presso l'università di Leeds, dove studio da tre anni. Nelle ultime cinque settimane ho studiato in Italia, a Perugia .

Tale dichiarazione completa quanto da me già dichiarato a proposito di Meredith Kercher e alla nostra amicizia. Ho reso la mia prima dichiarazione venerdì 2 novembre 2007 ai funzionari di polizia italiani.

Da quando sono tornata nel Regno Unito ho avuto modo di pensare a quanto successo e vorrei portare all'attenzione della Polizia quanto segue.

Ricordo una conversazione che ho avuto con Meredith, credo risalga più o meno al 6 ottobre 2007 . Eravamo al Merlin Pub e con noi c'erano anche Amy Frost, Sophie Purton e Natalie Hayward. Stavamo mangiando una pizza ed avevamo appena visto la partita di rugby Inghilterra – Australia. Credo fossero più o meno le 21.00. In quel momento Meredith richiamò la mia attenzione su un ragazzo che era entrato nel pub. Mi disse che si trattava di un uomo che si era recato nel suo appartamento insieme ad Amanda (Amanda era la ragazza che divideva l'appartamento con Meredith) . Avevamo discusso in precedenza sul fatto che Amanda avesse portato degli uomini nel loro appartamento, in diverse occasioni. Aveva incontrato questo tipo in un Internet - Café, per cui lo avevamo chiamato “internet man”.

Lo descriverei come un tipo sui 25-30 anni, alto circa ... (n.d.t. : non si comprende l'altezza precisa), corporatura media. Aveva i capelli corti, castani, un po' trasandati. Era di carnagione chiara, non sono sicura della sua nazionalità. Aveva una barba appena accennata. Era ben vestito, indossava pantaloni e scarpe con una giacca classica di colore marrone ma in tessuto casual.

Ricordo di aver visto questo ragazzo una settimana dopo, intorno alle 04.00 di mattina, il 14 ottobre 2007 , mentre uscivamo dal Gardisco, una discoteca a 25 minuti di auto da Perugia. La mia amica Sophie Purton si era sentita male ed era andata alla toilette della discoteca. Io e Meredith stavamo accompagnando Sophie fuori dalla discoteca per prendere l'autobus per tornare a Perugia. Il ragazzo che noi conoscevamo come “internet man” cercò di parlare con Meredith. Io dissi all' “internet man” : “No, scusa ma dobbiamo accompagnare a casa la nostra amica”. Una volta uscite dalla discoteca ci siamo rese conto di aver perso l'autobus. Poi abbiamo visto un ragazzo che io conosco come “Shakey”, (in seguito ho scoperto che potrebbe chiamarsi Isham). Ci ha offerto un passaggio per tornare a casa; l'auto era una familiare. Non guidava lui, guidava un suo amico. Posso solo dire che il ragazzo alla guida aveva la carnagione scura, capelli scuri, e portava occhiali. Durante la conversazione, mentre tornavamo a casa, Meredith chiese a “Shakey” “perché fosse in

discoteca". Lo fece in italiano. Lui rispose: "Ho tre lavori e lavoro in discoteca". Disse di essere uno chef, lavorava in discoteca e per quanto ne sappiamo lavorava in un negozio di abbigliamento chiamato "Sweet dreams" a Perugia. Non avevamo visto "Shakey" in discoteca per tutta la sera.

Ricordo un altro episodio quando ci trovavamo in una discoteca chiamata "Domus" a Perugia. Non ricordo né l'ora né il giorno ma so che ero con Sophie Purton, Meredith Kercher e 3 ragazze dell'Università di Manchester, le conosco solo come Samantha, Charlotte e ..... (n.d.t. : gli ultimi due nomi sono incomprensibili).

Quella volta successe una cosa : Meredith chiese a "Shakey" di ballare. A questo punto io mi ero voltata da un'altra parte, quando ho sentito Meredith gridare che "Shakey" si era tirato giù i pantaloni mostrando le mutande. Io non ho visto questo. Quella sera c'era con noi anche "Pisco", lo conosco come gestore del Merlin Pub.

Dopo la festa di Halloween nel nostro appartamento, siamo andate alla discoteca "Domus". Erano circa le 02.00 del 1° novembre 2007. Ero in compagnia di Sophie Purton, Meredith Kercher ed Amy Frost. Quella sera in discoteca ho visto un ragazzo che conosciamo come "Dj Naf", il quale lavorava al bancone del bar. Lo conosciamo perché lavora anche al Merlin Pub. Amy Frost mi disse di aver visto questo ragazzo flirtare con Meredith. In quella circostanza si era messo a tirare dei cubetti di ghiaccio in direzione di Meredith. In mia presenza, Amy Frost disse a Meredith Kercher : "Dj Naf ti fa il filo, penso".

La volta successiva che ho visto questo tipo è stato intorno alle 17.30 di venerdì 2 novembre 2007, mentre aspettavo che la Polizia mi passasse a prendere all'uscita dell'Università per Stranieri a Perugia.

In quella occasione, si è unito a noi anche "Pisco", il proprietario / gestore del Merlin, perché aveva parlato con Sophie Purton di cui era un buon amico ,dopo aver sentito della morte di una ragazza inglese. In compagnia di costui c'era anche "Dj Naf". Trovai il comportamento di "Dj Naf" un po' strano. Parlava con Pisco in italiano dicendo : "E' Meredith. E' lei". Poi si è addentrato nei particolari parlando in italiano e dicendo che era stato trovato un corpo. Poiché ero sconvolta e non sapevo che si trattasse di Meredith Kercher , ho detto a Pisco di dire a "Dj Naf" di tacere.

Descriverei "Dj Naf" come il tipico ragazzo mediterraneo, tra i 23 e 28 anni. Non è molto alto (?), ha capelli e occhi scuri e indossa gli occhiali. Normalmente veste casual, in jeans e maglietta. Quel venerdì portava un gran cappotto blu.

So che "DJ Naf" ci conosce come gruppo ma non che conoscesse bene Meredith.

Durante il volo di ritorno verso il Regno Unito, sabato 3 novembre, ero in compagnia di Amy Frost. Stavo leggendo un articolo sul "Corriere della Sera". Venivano riportate dichiarazioni rese da un certo Pietro Campolongo. Non conoscevo questo nome per cui chiesi ad Amy se lo conosceva.

Rispose di no. Una volta a casa parlai con la mia amica Sophie Purton che era in Italia. Mi disse che il nome di "Dj Naf" è Pietro. Le chiesi del cognome e lei disse che comunque poteva trattarsi di lui. Poi ho avuto modo di leggere su internet la dichiarazione di un uomo con lo stesso nome, che riportava informazioni più dettagliate su Meredith e sui suoi spostamenti. Questa cosa mi diede da pensare. Penso sia importante menzionare che giovedì 1° novembre, quando Meredith Kercher ha lasciato il nostro appartamento, non ha mai detto che stava per incontrare qualcuno e non ha mai affermato che sarebbe restata da sola nel suo appartamento quella notte. Quando ha lasciato il nostro appartamento non è stato ad un'ora stabilita oppure come se avesse un appuntamento pre-combinato.

Vorrei anche riferire che dopo aver reso la mia dichiarazione alla stazione di polizia italiana, sono stata fatta entrare nella sala d'aspetto; erano circa le 22.30 di venerdì 2 novembre 2007.

Nella sala d'aspetto c'era anche Amanda, la compagna di appartamento di Meredith. Non conosco il suo cognome. Quando sono entrata nella stanza, lei stava parlando ad alta voce a tutte le persone lì presenti, ossia le ragazze inglesi. Parlava in inglese. Diceva di essere tornata all'appartamento verso le 11.00 di mattina. Diceva che la porta dell'ingresso era aperta, che era andata nel bagno che lei e Meredith avevano in comune. Disse che aveva visto del sangue sul pavimento. Ricordo che disse di aver pensato che fosse sangue mestruale. Disse anche che poi si fece una doccia. Ricordo che disse di essere entrata nella camera di Laura e Filomena (le altre ragazze che vivono nell'appartamento). Disse che nel water c'era della "merda". Continuava a ripetere la parola "merda". Questo mi è sembrato uno strano commento da parte sua, in quanto so che Meredith aveva avuto una discussione con Amanda perché non scaricava lo sciacquone dopo aver usato il water, nemmeno quando era in fase mestruale. Meredith mi aveva detto che avevano discusso per questo motivo. Amanda continuava a parlare di come aveva trovato Meredith, sembrava orgogliosa di essere stata la prima a trovarla (?). Disse anche di aver visto il corpo di Meredith in un armadio (n.d.t. riflesso nello specchio di un armadio?), con una coperta/lenzuolo sopra di lei. Più tardi Filomena mi ha preso da una parte, dove potevamo parlare in privato, e mi ha detto di aver visto un piede di Meredith sul letto quando un poliziotto aveva aperto la porta della stanza di Meredith.

Il comportamento di Amanda mi è sembrato molto strano, nella stazione di polizia si comportava come se non fosse sconvolta. Sembrava che stesse..... (n.d.t.: seguono due verbi al gerundio incomprensibili). Il comportamento aveva colpito il mio gruppo di amiche.

Il comportamento di Amanda mi è sempre sembrato strano, anche prima di venerdì 2 novembre 2007. Sembrava un tipo un po' stravagante. Ricordo che la prima volta che ho avuto occasione di incontrarla, mangiavamo in un ristorante, quando all'improvviso cominciò a cantare (?) ad alta voce. Fu una cosa molto strana e fuori luogo.



Io credo e mi sento di poter affermare che, se Meredith avesse avuto intenzione di fare del sesso con qualcuno oppure se lo avesse fatto, me lo avrebbe detto.

After the HALLOWEEN party at our flat we went to the club "Darius". It was approximately 0200 hours

1 November 2007. I was in company with SOPHIE PURTON, MEREDITH KERCHER and AMY FROST. During this evening at the club I saw a male we know as "DI NAF" working behind the bar.

This male we know from MERLINS pub where he also worked. AMY PROST told me she had seen this

male flirting with MEREDITH. He has been throwing ice cubes at MEREDITH. In my company AMY

FROST said to MEREDITH KERCHER "DI NAF FANCY YOU I THINK"

The next time I saw this male was at approximately 1730 hours on Friday 2 November 2007 while waiting for the Italian Police to collect me from outside the language UNIVERSITY in PERUGIA. At this time "PISCO" the owner manager of MERLINS joined us because he had spoken to SOPHIE PURTON who he was close friends with after hearing of a death of an English girl. In company with him was "DI NAF". I found "DJ NAF" behaviour strange. He was speaking to "PISCO" in Italian saying "he is MEREDITH" "IT IS HER." He then went on to tell in Italian how a body had been found. As I was very upset and still unaware it was MEREDITH KERCHER I told "PISCO" to tell "DI NAF" to be

I would describe "DJ NAF" as a Mediterranean male aged about 23 to 28 years old. He is under 6ft tall he has dark hair and eyes and wears glasses. He normally dresses casually in jeans and a jumper. On Friday he was wearing a big blue coat.

I know that "DJ NAF" knew us as a group but not that he knew MEREDITH well. On my flight home to the UK on Saturday 3 November 2007 I was in company with AMY FROST. At this time I read an article in "CORRIERE DELLA SERA" there was a quote from a male named PIETRO CAMPOLONGO. I did not know this name so asked Amy if she knew who the male was. She replied "NO." On returning home I spoke to my friend SOPHIE PURTON who was in Italy. She told me she knows "DI NAF" first name is PIERO, I read her the surname and she thinks that is also his surname. I then went on to read a quote on the internet from a male with the same name detailing information about MEREDITH and her movements. This concerned me. I think it is important to mention that on Thursday 1st November 2007 when MEREDITH KERCHER left our flat she never mentioned she was going to meet anybody and she never stated she would be staying alone in her flat for the night. When she left our flat it was not a prearranged time or as for a prearranged meeting.

I would also like to mention that after my interview/statement at the Italian police station I went into the waiting room, it was approximately 2230 hours on Friday 2 November 2007.

In the waiting room was AMANDA — MEREDITH's flat mate. I do not know her surname. As I walked into the room she was talking in a loud voice to all the people in the room, the English girls. She was speaking in English. She was saying that she had returned to the flat at about 1100 in the morning. She went on to say that the front door was open, she went into the bathroom that her and MEREDITH shared. She said she saw blood on the floor. I recall being mentioned she thought it was menstrual blood. She then stated she went to have a shower, I then recall her mentioning going into the other bathroom that LAURA and PILOMSNA (other flat mate) had.

She said that here was "SHJT" in the toilet. She kept mentioning the word "SHLT". This seemed an odd comment to make as MEREDITH had had an issue with Amanda over not flushing the toilet after using it even for her period. I remember Meredith told me she had discussed this with her date. Amanda continued to talk about how the bitches found MEREDITH, she seemed

premises that she was the first to find her. She also said she had seen MEREDITH's body in the closet with a blanket/sheet over her. Later FILOMENA took me to the one side where we could speak privately and she told me she had seen MEREDITH's foot on the bed when she and a policeman had opened the bathroom door to MEREDITH's room.

I (eh) AMANDA'S behaviour was very strange in the police station she didn't seem to be behaving as if she was upset. She seemed to be laughing and staring at us, Her behaviour had upset my group of friends. AMANDA'S behaviour had always seemed strange to me before Friday 2nd November 2007. She seemed a little odd I remember on my first occasion meeting her while eating in a restaurant she burst into song loudly during the meal. It was out of place and very odd.

I also want to mention that I felt that if MEREDITH was going to have a sexual relationship with somebody she would have told me,
